## **ABOUT SPOTSYLVANIA COUNTY**

Spotsylvania County is located in Northern Virginia, midway between the Nation's capital of Washington D.C. and the State's capital of Richmond. The County covers over 400 square miles and has a 2020 population of 140,032 according to the U.S. Census Bureau April 01, 2020 census. In prior years, the County's growth rate resulted in the County being included in the rankings of the hundred fastest growing counties in the Nation. The County's growth can be attributed to several factors. The County is located along the I-95 interstate corridor with close proximity to businesses, industries, military installations, as well as federal and state governmental offices. Affordable housing, relative to the surrounding areas, has led many individuals and families to migrate to Spotsylvania County. Over half of the County's employed residents commute to work in the Northern Virginia, Washington D.C., or Richmond area. Within its boundaries, the County possesses the scenic beauty of Lake Anna, rural landscape, suburban amenities, and a wealth of historical attractions from the Colonial and Civil War eras. These resources also make the County a favorite tourist destination.

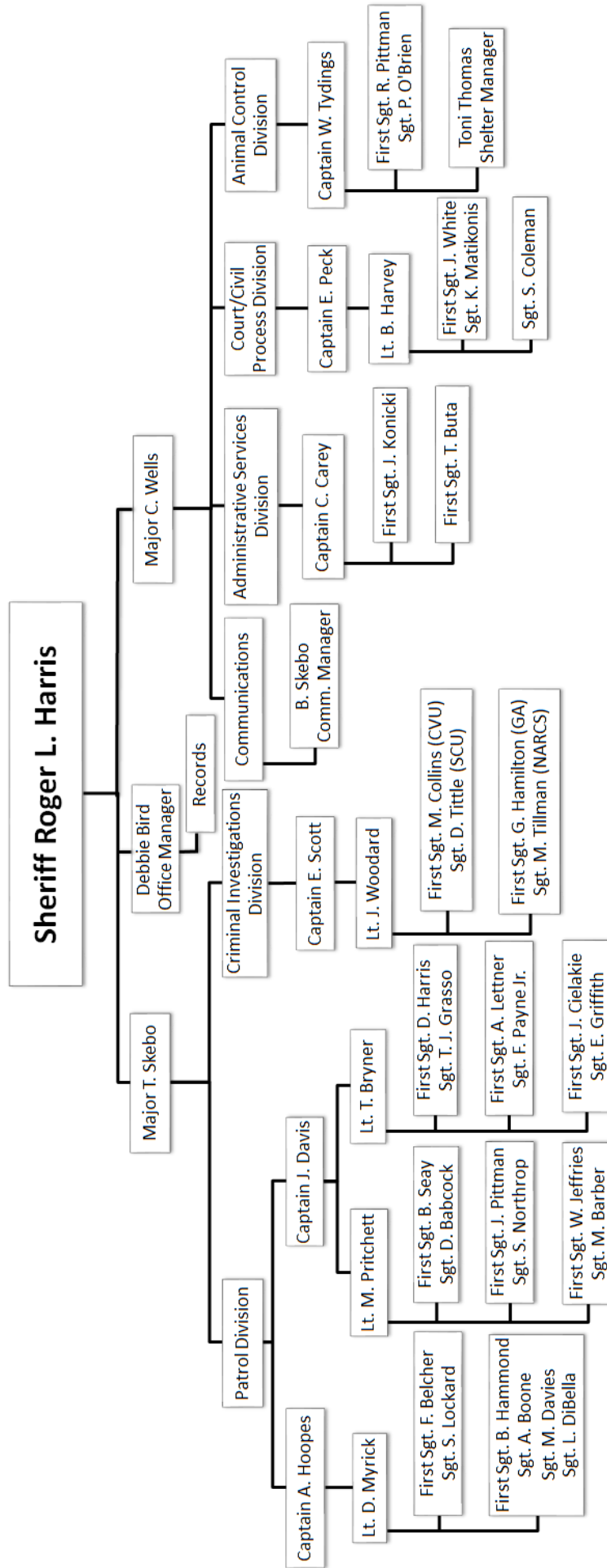

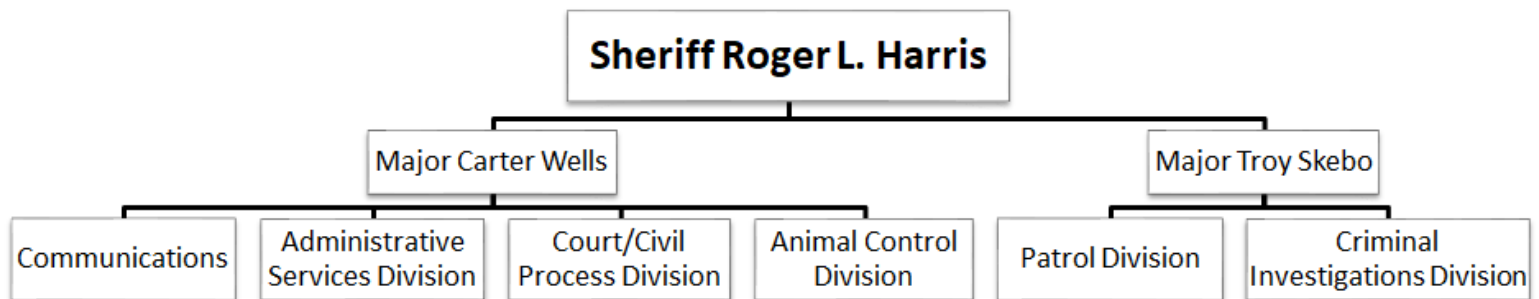

THE SHERIFF'S OFFICE

SPOTSYLVANIA COUNTY, VIRGINIA



The Sheriff is a constitutional officer of the Commonwealth of Virginia and is not an officer or employee of the County. The Sheriff is elected by the voters of Spotsylvania County every four years. The duties, responsibilities, and privileges are set out in the State Constitution, the Code of Virginia, and supplemented by local ordinances. The Sheriff provides law enforcement services to the citizens of the County, including the enforcement of all State and County criminal codes, serves civil and criminal papers, provides enforcement of all State and County animal codes, supervises the operations of the County's animal shelter, and maintains the security of the courts operating within the County.

There are five divisions within the Sheriff's Office that together, serve all the law enforcement functions described above: Patrol, Criminal Investigations, Animal Control, Courts Security and Civil Process, and Administrative Services.

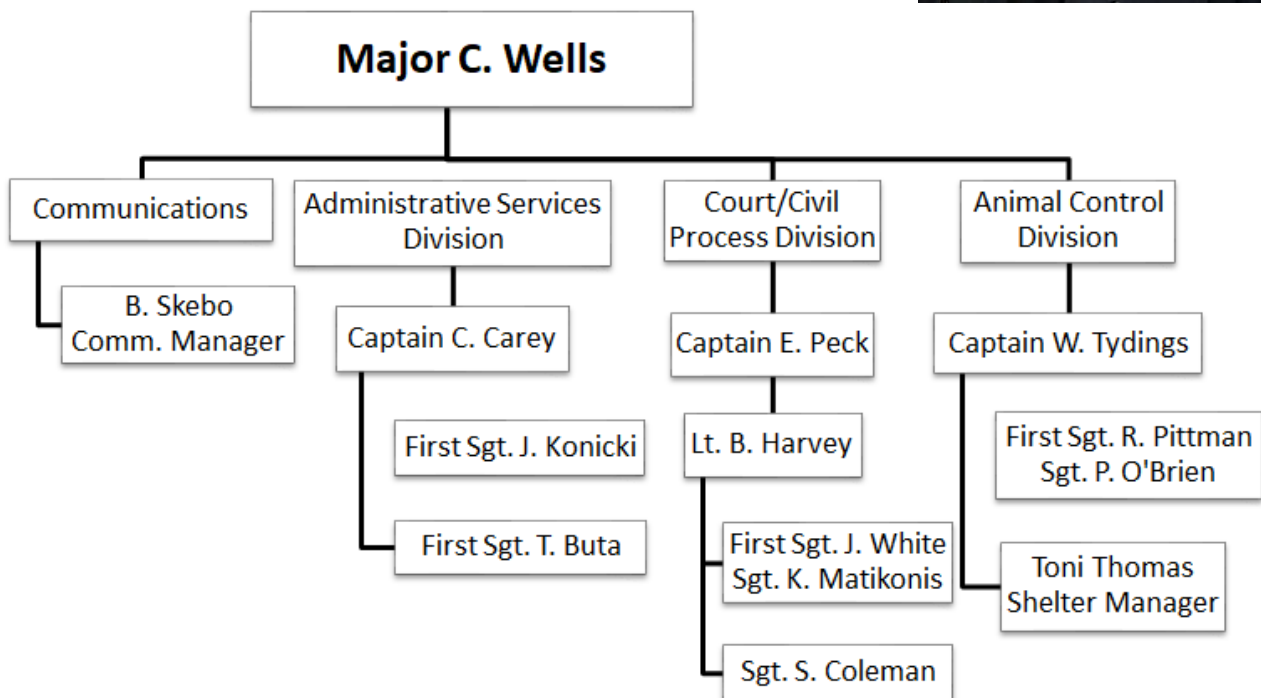
Within these Divisions are additional specialty functions. The Emergency Communications Center is a 24/7 operation that serves as the 911 answering point for calls for service and the dispatching of public safety services. Some of the other specialty functions within the divisions are: Special Weapons and Tactics (SWAT), K9 Unit, Ground Search and Rescue Team, Street Crimes Unit, Narcotics Unit, Traffic Services Unit, Motor Unit, Crisis Negotiations Team, Marine Patrol Unit, Dive Team, School Resource Unit, Civil Disturbance Unit, Bicycle Team, Drone Team, Honor Guard, and Crime Prevention Unit.

# PATROL DIVISION

## 2022 NOTABLE EVENTS AND ACHIEVEMENTS

- ♦ CY22 Patrol handled 112,271 calls for service.
- ♦ CY22 the Patrol Division worked 4,474 crashes which is down 15% from last year's 5,280 crashes.
- ♦ CY22 Patrol made 245 DUI/DUID arrests, down 27% from last year's 334 DUI/DUID arrests.
- ♦ FY22 the Patrol division worked a total of 27,976 overtime hours with 11,481 hours reimbursed.
- ♦ NARCAN was administered 36 times resulting in 30 lives saved.
- ♦ Project Lifesaver participation is currently 135 clients.







The Patrol Division is dedicated to improving the quality of life for the citizens of Spotsylvania County through a partnership with the Community. The Division's primary objective is to carry out this partnership through swift response to calls for service and proactive initiatives. To carry out this mission, the division is broken down into three platoons.

**PATROL PLATOONS-** The Patrol Division is divided into three platoons. Two operate on a permanent schedule of three, 12 hour shifts; days, evenings, and midnights. These two platoons provide first response to calls for service from citizens and preventive patrol through their presence in the County. The third platoon consists of specialized units to include Traffic Services Unit, School Resource Unit, and Part-Time/Auxiliary Unit.

**TRAFFIC SERVICES UNIT-** The Traffic Services Unit is dedicated to promoting and improving traffic safety within Spotsylvania County. Within this unit, there is a Motor Squad, Motor Carrier Units, Parking Enforcement, and other traffic crash investigators. This unit enforces traffic and safety laws, responds to all crashes within the County, funeral escorts, and all other traffic related calls. The Spotsylvania Tow Board is staffed by Traffic Services Unit members and is currently comprised of seven members; made up of 3 companies, 3 law enforcement members (2 Sheriff's Office, 1 Virginia State Police), and 1 citizen volunteer. The tow board is the regulatory authority for all Sheriff's Office and Virginia State Police (VSP) requested tows. The tow board oversees citizen complaints with regards to Sheriff's Office or VSP tows. Also within their purview is the initial body for consideration in updating and changing the laws associated with the Spotsylvania County Tow Ordinance. The Sheriff's Office conducts quarterly inspections of all 19 towers and their equipment to ensure they are within required specifications of Spotsylvania County Tow Ordinance.



**SCHOOL RESOURCE UNIT-** There are currently 33 School Resource Officers (SRO) which includes 15 DARE certified deputies. The primary objectives of the SRO program include: assisting school administration in fostering a safe, appropriate school environment; acting as an advocate for any child who may be a victim of suspect criminal activity; and promoting a relationship of trust while enhancing the lines of communication among the Sheriff's Office, County Public Schools, students, and parents.

**PART-TIME/AUXILIARY UNIT-** Deputies who donate their time or become part-time employees are a valuable asset. These individuals assist with special events, Search and Rescue, Marine Patrol, and help with staffing shortages in patrol.

In addition to the Patrol Division, Traffic Services Unit, School Resource Unit, and the Part-Time/Auxiliary Unit, there are other vital specialty and support units within the Patrol Division. Among these are:

- ♦ ***Bike Patrol Unit-*** The Bike Team is a twelve member unit. All members have regular duty assignments and are called upon during special events or enforcement details. The purpose of the Bike Team is to take deputies out of their patrol vehicles and make them more accessible to the public they serve. Once in operation, participating deputies soon learned that patrolling the County in this manner is effective in locating and detecting crime.
- ♦ ***Special Weapons and Tactics (SWAT)-*** The primary responsibility of this team is to increase the likelihood of safely resolving critical incidents. The team specializes in high risk felony apprehension, hostage negotiations, armed criminal activities, and other tasks. The duties of this team also include hostage rescue, barricades, high-risk apprehension, dignitary protection, terrorism response, and special assignments. All team members have regular duty assignments and are on-call at all times. SWAT maintains and issues various equipment and supplies that tactical officers use in handling barricaded persons, hostage situations, and other special incidents.
- ♦ ***K9 Unit-*** This unit was established in 1974 and currently consists of six canines and six handlers. The K9 Unit is a full-time continuously operating unit within the patrol division. The unit consists of five canines crossed trained in the areas of patrol and narcotics detection, and one bloodhound. The canine breeds vary ranging from German Shepherds, Dutch Shepherds, Belgian Malinois, and Bloodhounds. This unit utilizes their special abilities to locate wanted felons, missing persons, narcotics, and evidence. The handlers and canines undergo a strenuous program during which the teams are instructed in basic obedience, agility, handler protection, narcotics detection, tracking, building searches, veterinary first aid, and legal issues. The success of this unit can be attributed to the support provided by our citizens, schools, businesses, and local organizations.
- ♦
- ♦ ***Crisis Negotiations Team (CNT)-*** Team members undergo specialized training based on problem resolution and psychological tactics. This training is focused on convincing the subject(s) involved to resolve the situation peacefully. Training is enhanced by joint training with SWAT. These monthly training sessions are scenario based and verbal crisis management techniques are practiced. This training is necessary in order to maintain the highest level of competence and readiness.







- ♦ ***Search and Rescue Team-*** This team was first established in 1997 and is designed to locate lost or missing persons with certified search and rescue personnel. The Search and Rescue Team also participates in rescues within other localities as part of the County's Mutual Aid Agreement with the Virginia Department of Emergency Management.
- ♦ ***Project Lifesaver-*** The Spotsylvania Project Lifesaver program assists families and caregivers of individuals who have a propensity to wander. These individuals are provided with a wrist or ankle band that contains a silent transmitter. In the event that the individual becomes missing, the Sheriff's Office can be contacted and equipped with a special receiver and locate the missing individual. Project Lifesaver has had a 100% recovery rate for individuals enrolled in the program. In addition to providing peace of mind to the caregiver, this program has also mitigated the time and money needed to coordinate a major rescue.
- ♦ ***Honor Guard-*** The Honor Guard is an eight member unit. All members have regular duty assignments and are on-call at all times. The Honor Guard is ceremonial units composed of deputies who are highly motivated and maintain exceptionally high standards of appearance. The unit provides funeral honors for fallen officers, military veterans, and civilian dignitaries. The Honor Guard may also serve as the "guardians of the colors" by displaying and escorting the national flag on ceremonial occasions at official functions.
- ♦ ***Dive Team-*** Spotsylvania County contains numerous ponds, rivers, creeks, and lakes to include Lake Anna. Lake Anna is a 1,300 acre body of water. The Dive Team provides rapid response to any water related incident within the County or in response to mutual aid requests. The divers assist citizens, recover equipment, evidence, and personnel. Team members have regular duty assignments and are on-call at all times.
- ♦ ***Marine Patrol Unit-*** The Marine Patrol Unit patrols any body of water within the County and other jurisdictions in which we have a mutual aid request. The unit is responsible for boating under the influence (BUI) enforcement, boating laws of Virginia, and assisting stranded citizens on the lake. The unit responds to boat crashes, shore incidents, and patrols the marinas, beaches, and parks. This unit works with Virginia Fish and Wildlife, Louisa County Sheriff's Office, the United States Auxiliary Coast Guard, and other law enforcement agencies on the waters within the Commonwealth. The Marine Unit drives the dive boat for the associated team and provides security during dive missions.



# CRIMINAL INVESTIGATIONS DIVISION (CID)

## 2022 NOTABLE EVENTS AND ACHIEVEMENTS

- ♦ 17 full time-detectives, 3 part-time detectives, and 5 deputies collectively worked 1,452 cases.
- ♦ Seized \$15,939.47 and 4 vehicles from 1 narcotics incident.
- ♦ Investigated 5 homicides.

The Criminal Investigations Division (CID) handles the assignment, closure, and filing of all cases within the Sheriff's Office. CID ensures proper procedures and policies are followed during investigations, review and assign cases, investigate and close cases, perform various inspections of personnel and equipment, and assist personnel with advice and guidance in their investigations and daily activities. Within the division there are specialized units.





The specialized units within the Criminal Investigations Division are as follows:

- ♦ **General Assignment Unit-** Detectives assigned to this unit handle the more complex cases to include larcenies, burglaries, robberies, auto theft, rape, malicious assaults, and homicides. Cases that involve suspects or witnesses outside of the County's jurisdictions and those cases which involve extensive investigation, follow-up, forensics, and/or evidence gathering are assigned to this unit.

- ♦ **Special Investigations Unit-** Detectives assigned to this unit have specialized training to address crime related to narcotics, street crimes, and gangs.

- ♦ **Forensic Unit-** This unit is responsible for conducting crime scene investigations to discover, develop, collect and evaluate physical evidence which may include blood and other

body fluids, hair, fiber, paint chips, glass fragments, fire accelerants, soils, firearms, documents, fingerprints, and footwear impressions. Several of the detectives have been deemed by the Virginia Circuit Courts as experts in several fields of Forensic Science to include blood splatter, firearms, and bullet trajectory. In addition to crime scenes, the unit is responsible for the follow-up investigations of criminal cases where a computer has been used to perpetrate the crime. These cases can involve computer intrusion, online auction fraud, email threats and harassments, identity and credit card fraud, theft of intellectual property, software or music piracy, possession or distribution of child pornography, and online child solicitation.

- ♦ **Crime Analysis Unit-** The Crime Analysis Unit is responsible for reviewing all offense reports and tracking any trends that develop within the County by collecting, collating, and analyzing local and regional crimes. The data that is provided assists operational personnel in meeting their tactical crime control, criminal apprehension and crime prevention objectives, and to assist command staff and administrative personnel in planning and strategic decision-making.

- ♦ **Child Victim Unit (CVU)-** This unit consists of highly specialized detectives that investigate cases involving sexual assault/abuse, physical abuse, domestic abuse, and any other crimes or neglect against children. Likely the most sensitive area of investigation for detectives. This unit is essential when investigating cases involving children as proper, immediate response is critical to the outcome of these cases.



# ANIMAL CONTROL DIVISION

## 2022 NOTABLE EVENTS AND ACHIEVEMENTS

- ♦ Live release rate was 92%.
- ♦ The shelter received 6,723 visitors with 624 customer adoptions and 556 rescue group transfer adoptions.
- ♦ Animal Control Deputies responded to a total of 9,742 calls for service within Spotsylvania County (8,489) and the City of Fredericksburg (1,253).
- ♦ The division also conducted education programs in schools and at other events.

The Animal Control Division is responsible for the enforcement of all State and County animal codes and supervises the operation of the County's Animal Shelter. The Animal Control Division oversees the collection of dogs, cats, and livestock running at large as well as the collection of sick or injured animals. The division receives and investigates reports of suspected animal cruelty or neglect in addition to calls received for animal bites, barking dogs, or vicious animals.

Currently, the Animal Shelter is located at 450 TV Drive and houses all animals that are collected by Animal Control Officers or turned in by citizens. Animals are held in accordance with state requirements and are either redeemed by the owner or adopted.







The Animal Shelter also houses a low cost spay/neuter clinic which is operated by the Lionhearts, Inc., a local humane organization. With the exception of puppies and kittens that are too young, all dogs and cats adopted from the shelter are neutered or spayed.

The division conducts a rabies clinic each year during the spring and fall in order to enable citizens to vaccinate their pets at a low cost. The division also conducts public education programs such as rabies awareness and proper animal care/treatment in the public schools and at special events.

### ***Animal Control Volunteer Program***

Participation in the Animal Control Volunteer Program supports the division's efforts in the safe and efficient operation of the Animal Shelter with the ultimate goal of humane treatment and care for animals. To accomplish this goal, the division is committed to effectively utilizing properly trained volunteer resources.





# COURTS AND CIVIL PROCESS DIVISION

## 2022 NOTABLE EVENTS AND ACHIEVEMENTS

- ♦ In CY22, the Courts Division continued to handle high profile and security sensitive trials without incident.
- ♦ In CY22, the Courts, Civil Process, and Warrants Division maintained an outstanding record without any notable complaints and a professional division with increased productivity.
- ♦ In CY22, the Courts Division successfully completed the expansion of both General District and Juvenile & Domestic Relations District Court. Currently, upgrades are being made to the General District Clerk's Office and the Juvenile Detention's holding cells.



## ***Court Security***

The Courts, Civil Process, and Warrants Division provides law enforcement services to the citizens of the County by serving both civil and criminal papers. They protect and maintain security of the courts operating within the County. Court Security has assigned deputies whose responsibilities range from weapon screening, maintaining courtroom decorum, and essential public safety as well as law enforcement services. The deputies ensure that the courthouse environments are safe and secure for the judiciary, court support staff, and the public. Court security deputies are responsible for the physical protection of the judges, court personnel, attorney's, witnesses, juries, and the citizens who have business within the Spotsylvania County Judicial Center. Visitors to all courts may experience a delay upon entering due to the necessity of being screened as they enter any courthouse building.

The Courts Division is also responsible to manage the transport of prisoners to accommodate respective court dates, emergency custody orders (ECO), and temporary detention orders (TDO). In 2022 this division conducted 575 state transports, 37 extraditions, and 51 TDO's.

The Courts Division processed 2,916 concealed weapons permits.

## ***Civil Process and Warrants***

The Spotsylvania County Sheriff's Office is responsible for serving warrants and all civil process documents as directed through the courts system. These papers include, but are not limited to, subpoenas, notices, orders, criminal warrants, and summonses for both civil and criminal cases. They are also responsible for the execution of evictions, levies, seizures, and public auctions. There was a total of 39,001 documents served in 2022.

The Civil Process Unit is also responsible for processing the Counties distress warrants for the County Treasurer, to those who owe back taxes. This Unit served 72 warrants, recovering \$353,428.71 in delinquent taxes during 2022.

The Criminal Warrants Unit processed 9,802 warrants for the Sheriff's Office for calendar year 2022. The warrants personnel conduct research, code, verify, record, and make entries into the National Criminal Crime Center (NCIC) and the Virginia Crime Information Network (VCIN). This Unit also assists in the coordination and completion of audits conducted by the FBI and Virginia State Police.



# ADMINISTRATIVE SERVICES DIVISION

## 2022 NOTABLE EVENTS AND ACHIEVEMENTS

- ♦ Reviewed and successfully hired 44 applicants.
- ♦ Processed 14,112 items in evidence.
- ♦ Worked with the Federal Trade Commission to disseminate information to citizens regarding different types of scams and identity theft.
- ♦ Provided 5 RAD (Rape Aggression Defense) classes to citizens.
- ♦ Hosted monthly meetings for Neighborhood Watch, Apartment Watch, Business Watch, and Worship Watch.
- ♦ Collected 852.2 pounds of drugs and 370 pounds of sharps during the National Drug Take Back Program.
- ♦ Provided approximately 15,500 pounds of food for the Food Bank Program.
- ♦ Assisted the food bank with the distribution of 55,000 pounds of food and supplies.
- ♦ Served 918 children, 99 teenagers, and 67 senior citizens during Operation Blue Christmas.
- ♦ Provided school supplies for School Resource Officers for their Back to School Drive.
- ♦ Received \$415,156.00 in new grant awards.





Under the direction of Sheriff Harris, the Administrative Services Division (ASD) was established in January 2012. The division strives to offer education, safety programs, and events that bring the community together. Sheriff Harris believes that a safe, effective community is achieved through teamwork between the Sheriff's Office and citizens. The division is responsible for the following functions:

- ♦ **Training-** Training is an integral part of any effective law enforcement agency. The training coordinator ensures that all employees maintain their state required in-service hours, retains a positive relationship with the Regional Training Academy, and coordinates basic and advanced level instructors for law enforcement training.
- ♦ **Crime Prevention-** The Crime Prevention Unit offers valuable programs, lectures, displays, seminars, crime prevention, and safety tips to all citizens and community groups. The Unit coordinates or participates in the following community programs: Crime Solvers, Crime Council, Neighborhood Watch, Business Watch, Apartment Watch, Worship Watch, Citizen Advisory Board, Special Olympics, and TRIAD.
- ♦ **Evidence and Property-** The Evidence and Property function maintains a safe, efficient storage and retrieval system for evidence and other valuable items that are in the custody of the Sheriff's Office. The Evidence Custodian ensures that the proper chain of custody is accurately documented for evidence presentation and admittance in court.
- ♦ **Recruitment and Hiring-** The Recruitment and Hiring function is responsible for recruiting, processing, and forwarding recommendations of the best qualified candidates to the Sheriff for his review and selection. The Sheriff's Office conducts a regimented, rigorous selection process which affords equal opportunity to every applicant regardless of race, creed, color, gender, national origin, or age. All applicants are required to meet the minimum qualifications at each stage of the process.
- ♦ **VIPS-** The VIPS (Volunteer in Police Services) Program provides support and resources for agencies interested in developing or enhancing a volunteer program and for citizens who wish to volunteer their time and skills with a community law enforcement agency. The program's ultimate goal is to enhance the capacity of state and local law enforcement to utilize volunteers.





In addition to the above functions, this division is also responsible for the promotional processes, awards ceremony, equipment and uniform ordering, issuance, inventory, grant administration, social media, vehicle fleet, and accreditation.





# EMERGENCY COMMUNICATIONS CENTER

BECKY SKEBO

## 2022 NOTABLE EVENTS AND ACHIEVEMENTS

- ♦ Answered 54,025 emergency and 130,077 non-emergency telephone calls.
- ♦ Of the 184,102 calls answered in 2022 we dispatched 112,271 calls for service for the Sheriff's Office, 23,065 for Fire/Rescue, and 553 Crime Solver Tips.
- ♦ Processed 117 text-to-911 interactions.
- ♦ Upgraded 911 phone system technology by implementing NG911 technology.
- ♦ Implemented Quality Assurance and Management program for fire and emergency medical calls.
- ♦ Organized and implemented an externship program with our Spotsylvania County High Schools.
- ♦ Revamped and streamlined our hiring process with a focus on recruitment strategies.

The Emergency Communications Center (ECC) is staffed twenty-four hours a day, seven days a week. The ECC is responsible for answering all 911 calls for the County, as well as the administrative numbers for the Sheriff's Office. The ECC provides radio communication services for the Sheriff's Office, the Department of Fire, Rescue and Emergency Management, the Spotsylvania Volunteer Fire Department, and the Spotsylvania Volunteer Rescue Squad. Our staff consists of professional, trained employees that provide rapid and convenient access to public safety for the citizens of this community and those passing through.





# AUXILIARY

## SPOTSYLVANIA COUNTY SHERIFF'S OFFICE

Article 4, §15.2-1731 of the Virginia State Code provides for the establishment of an auxiliary (or reserve) police force. All members of the Sheriff's Office auxiliary force shall have the same power and authority as the regular police force, provided that each auxiliary deputy has met the training requirements of a law enforcement officer. As such, the Sheriff's Office shall equip each auxiliary deputy in the identical manner as a regular deputy sheriff and supply basic, advanced, and ongoing training to all auxiliary deputies.

The auxiliary deputy shall be bound by the rules, regulations, policies, and directives of the Sheriff's Office and shall be issued a copy of the same. When on duty, the auxiliary officer shall carry out the full responsibilities of a sworn deputy without limitations, except as provided by code or statute. The auxiliary deputy shall obey the lawful orders of those appointed over him or her.

In 2012, Sheriff Harris reestablished an auxiliary force. The office currently has two (2) sworn auxiliary members. These individuals provide assistance at no salary cost to the community and are true assets to the office.

# ACCREDITATION

## SPOTSYLVANIA COUNTY SHERIFF'S OFFICE

The Spotsylvania County Sheriff's Office has been accredited by the Virginia Law Enforcement Professional Standards Commission (VLEPSC) since 2006. VLEPSC was established to provide law enforcement agencies in the Commonwealth with an avenue for demonstrating that they meet commonly accepted standards for effective and efficient agency operation.

VLEPSC has four sections of standards: administration, operations, personnel, and training. The entire Sheriff's Office must meet elements of each of these standards and provide proof of adherence to them on an annual basis. However, the primary responsibility for accreditation falls upon the Administrative Services Division to ensure that the process and its deadlines are met. Re-accreditation, or inspection, of a law enforcement agency participating in the VLEPSC program occurs every four (4) years. Each re-accreditation team consists of three (3) VLEPSC members which are not routinely associated with the Spotsylvania County Sheriff's Office. These members are VLEPSC certified assessors and master assessors, with one of the participating members acting as a team leader. This team leader then directly reports to the VLEPSC Program Accreditation Manager on the status of the participating agency and generates a report to be presented to the Executive Board (consisting of active Sheriffs and Chiefs of Police) prior to receiving a re-accredited certification. The Spotsylvania County Sheriff's Office underwent an intense inspection from November 15, 2022 - November 17, 2022 and was presented with our re-accreditation on December 01, 2022 by the Executive Board. Upon receipt of the accreditation award, a new accreditation term begins and remains in effect until the next re-accreditation inspection is conducted. Currently, the Spotsylvania County Sheriff's Office is in our fifth term of accreditation and is scheduled to under-go a re-accreditation inspection in November 2026.

# IN MEMORIAM

## SPOTSYLVANIA COUNTY SHERIFF'S OFFICE



### **DETECTIVE RICHARD SAMUELS**

*END OF WATCH SEPTEMBER 22, 1988*

While waiting to testify at a trial, a prisoner broke free of other deputies and fled the Courthouse area. Detective Samuels chased the prisoner who was running towards a neighboring elementary school. During the pursuit, Detective Samuels suffered a fatal heart attack. Other deputies apprehended the suspect inside of the school. At the time of his death, Detective Samuels was survived by his wife, son, and daughter.



### **DEPUTY DEAN RIDINGS**

*END OF WATCH JUNE 19, 2010*

Deputy Ridings was conducting marine patrol on Lake Anna with another deputy when their boat was struck by a large wake causing it to turn sideways. Deputy Ridings hit his head and his partner was thrown overboard. Other boaters assisted his partner out of the water and back into the boat. Upon returning to shore, both deputies were transported to the hospital where Deputy Ridings succumbed to his injuries. At the time of his death, Deputy Ridings was survived by his wife, two sons, and three grandchildren. Both of Deputy Ridings' sons serve as deputies with the Sheriff's Office.



### **DEPUTY BRYAN BERGER**

*END OF WATCH APRIL 28, 2014*

Deputy Berger suffered a fatal heart attack while participating in physical training exercises. He was warming up for officer survival exercises when he became ill and collapsed. He was transported to the hospital but doctors were unable to revive him. Prior to being a deputy, he worked for the Sheriff's Office as a dispatcher. At the time of his death, Deputy Berger was survived by his wife and parents.

- ♦ Administrative and investigative efficiency of police agencies;
- ♦ The organization and cooperation of adjoining and overlapping police jurisdictions;
- ♦ Attitudes and policies of the courts, prosecutors and corrections;
- ♦ Citizen attitudes toward crime and police;
- ♦ Crime reporting practices of citizens.
